

# SCCPTA Advocating Life Safety Resolution to Florida PTA

SCCPTA will have a first at the Florida PTA Conference this July - a Resolution that our county is sponsoring for Florida PTA to consider for adoption. This initiative has been led by Leanne Briatico, SCCPTA Teacher Representative and 3<sup>rd</sup> Grade Teacher and Teacher of the Year at Crystal Lake Elementary, and Katie Murphy, SCCPTA Secretary. The details of the resolution as presented at the SCPS Board Meeting on February 21, 2023, are below. Thank you to Leanne and Katie for all your hard work!

Resolution proposed to Florida PTA:

# **Life Saving Training and Devices**

**WHEREAS,** Students may experience life threatening situations in schools such as choking, drug overdose, and injuries. One leading cause of children's and teen's accidental death is choking. At least one child dies from choking on food every five days in the U.S, and more than 12,000 children are taken to the hospital emergency room each year for food-choking injuries; and

**WHEREAS,** The Florida Medical Examiners Commission reported almost 500 deaths of people aged 0 - 25 years old were related to opioids for a six month period from January to June 2021. Furthermore, of the deaths related to fentanyl, 95% were accidental. In the school year 2020-2021 there were over 5,000 reported incidents of students' drug possession in schools; and

**WHEREAS,** Over 20% of high school students in Florida reported being in a fight in 2019. In the 2020-2021 school year, there were almost 9,000 fighting incidents reported in Florida schools; and

WHEREAS, We recognize a school employee is often the only adult present with a group of children during the school day, and immediate attention from bystanders is critical during all emergency situations. Choking, bleeding, not breathing, lack of pulse, overdoses, and other emergencies can become life-threatening prior to the arrival of emergency medical services (EMS); and

**WHEREAS,** Bystanders need training, practice, and access to quickly and appropriately perform life-saving techniques and use life-saving devices. With this, bystanders are more likely to render first aid for emergency situations; the efficacy increases when proper life-saving devices and materials are available; and

#### THEREFORE BE IT

**RESOLVED,** that Florida PTA and its constituent associations advocate for schools to fund and expand their life saving trainings beyond the use of CPR and AEDs to include all school staff and students (with parents' permission) throughout K-12 education to be trained on emergency interventions such as choking relief, bleed kits, and overdose relief; and be it further

**RESOLVED,** that Florida PTA and its constituent associations advocate for the funding and placement of fully stocked first aid kits and life saving devices in readily accessible locations throughout schools and school properties. The kits should also include simple pictorial and written directions for these devices and life saving techniques, e.g. choking relief; and be it further

**RESOLVED,** that Florida PTA and its constituent associations facilitate trainings regarding life saving techniques and devices for stakeholders and community members.

<u>CS/CS/HB 7039/SB 1424</u> emphasize identifying math deficiencies in primary grades.

<u>CS/HB 733/SB 1112</u> Middle School and High School Start Times— Healthy Sleep for Adolescents.

HB 891/SB 1564 Year-round School Pilot Program

HB 551/SB 804 Required African-American Instruction

HB 287/SB 294 Instruction in the History of Asian

Americans and Pacific Islanders

HB 863/SB 832 Holocaust Remembrance Day

HB 141/SB 196 Guidance Services on Academic and

Career Planning enhances knowledge of acceleration and CTE options

CS/HB 455/SB 1468 Career-themed Courses enhances awareness of CTE offerings from middle school CS/HB 703/CS/SB 478 Early Childhood Music Education Incentive Program introduce to the arts at a young age CS/CS/HB 19/CS/SB 636 Individual Education Plans—parents and developmentally challenged students to be aware of legal changes at age 18.

### **FL PTA OPPOSES**

<u>CS/CS/CS/HB 1</u> Education—PASSED Legislature; next action will be by Governor.

<u>HJR 31/SJR 94</u> Partisan Elections for Members of District School Boards school board members/candidates according to political ideologies

<u>CS/CS/HB 633/SB 1236</u> this bill eliminates school district financial penalties for exceeding class sizes.

CS/CS/HB 1069/CS/SB 1320 expansion of HB 1557 (Parental Rights in Education) that does not correct the vagueness of last year's bill by defining what constitutes "instruction" in sexual orientation or gender identity.

HB 1423/SB 1438 Gender Clinical Interventions interferes with parent's right to determine the care of their child.

HB 459/SB 1654 Allowing computer science credits to be substituted for foreign language credits.

# **Funding Bills**

## **FL PTA OPPOSES**

<u>HB 1259/SB 1328</u> Education Funding would make sharing of public school capital outlay tax revenues with charter schools mandatory, regardless of how much money given by state; no requirement for charter school capital plan; amount of allocation determined by number of enrolled charter school students rather than by need.

<u>CS/CS/HB 143/CS/SB 204</u> Monitor of Children in Out-of-Home Care <u>HB 1339/SB 1306</u> mandate adoption agencies to pre-screen prospective parents that a list could be established in advance of need.

<u>HB 1007/CS/SB 1064</u> Children Removed from Caregivers provide trauma-informed medical and mental support

<u>CS/HB 1557/SB 1690</u> this would require the posting of signage warning of human trafficking in state-supported facilities housing children and abused women.

<u>HB 195/SB 178</u> allow schools that serve as emergency shelters to install solar panels

HB 263/SB 1544 provide for defibrillators on school campuses as well as training of school staff

<u>HB 1211/SB 1374</u> increasing the age requirements for child restraint devices in personal vehicles.

<u>CS/HB 657/CS/CS/SB 588</u> allow for electronic monitoring of school zones and the issuance of citations for violations of 10 mph over the limit.

<u>CS/HB 741/SB 766</u> allows for monitoring of vehicles passing a school bus stopped

<u>CS/HB 301/CS/SB 212</u> providing funds to school districts to create standardized maps of school campuses for use during emergencies.

<u>HB 379</u> gives teachers more power about how students use devices and social media at school, **SIGN INTO LAW 5/9/32** 

CS/HB 591/SB 792 Social Media Protection for Minors

HB 699/SB 662 Student Online Personal Info Protection

CS/HB 655/SB 914 Suicide Prevention

## **FL PTA OPPOSES**

CS/HB 221/CS/SB 214 Sales of Firearms and Ammunition disallowing credit card companies from flagging large purchases of firearms and/or ammunition with a special code.

CS/HB 543/CS/SB 150 allowing for permitless carry. Already passed the House. HB 1543 lowering the age increase in long gun purchase eligibility back down from 21 to 18.



# Additional Bills Signed into Law on May 9, 2023

- <u>HB 1035</u> provides for a teacher apprenticeship program and authorizes the Office of Inspector General to investigate allegations and reports of suspected violations of rights.
- SB 256 bans the teachers union from automatically taking union dues out of their paycheck.
- HB 477 will put stricter term limits on school members. Eight years will now be the maximum.
- CS/HB 1537 allows students to take a different test than the SAT or ACT to qualify for Bright Futures scholarships

As part of a cooperative agreement to implement the USDA Food and Nutrition Service's <u>Healthy Meals</u> <u>Incentives Initiative</u>, Action for Healthy Kids is offering competitive grants, up to \$150,000 per SFA, to small and/or rural school food authorities to support efforts to improve the nutritional quality of their school meals. 
#### Is your SFA eligible to apply? See the Grant Eligibility Requirements below:

- Must participate in the National School Lunch Program and/or School Breakfast Program
- Must meet the definition of small and/or rural (see below).

**Small School Food Authority:** SFA with an enrollment of less than or equal to 5,000 students. **Rural School Food Authority:** The majority of students within the SFA are enrolled in a rural school as defined by a locality code of 41, 42, or 43, according to the <u>National Center for Education Statistics online tool</u>.

You must apply as a school food authority for this grant; individual schools are not eligible entities.

The Dividends Program is the SCPS Volunteer Program for anyone who would like to volunteer with our schools. Every potential volunteer needs to apply and receive their approval prior to volunteering in-person. And, of course, each volunteer must complete a new Dividend application each school year.

The Dividends Program ensures our students are safe and that volunteers check-in when they are on campus. SCPS keeps a record of volunteer hours that helps with eligibility for grants and other programs.

#### And... Did You Know?

Dividends can (and should!) log hours spent volunteering from home. Dividends can log hours spent in PTSA/PTSA meetings, Board meetings, making posters and decorations, prepping budget reports (we see you Treasurers!), and so much more! When we log our off-campus hours, we will increase our eligibility for grants and educational programs for our students.

#### Here's how to log volunteer hours completed off campus:

- Go to <u>Raptor</u> and Login using the ID and password provided by your Dividend registration. First time Dividends will set this up once their Dividend application has been processed. If you need assistance with your login, email <u>misa mills@scps.k12.fl.us</u>
- Upon login, you are directed to your Personal Information. If PTA/PTSA Event is not listed under Function, email <u>misa mills@scps.k12.fl.us</u> to have it added to your profile.
- 3. Click on Hours at the top of the screen
- 4. Click on Add Hours
- 5. Enter the following:
  - a. Past Event Event Not Listed Here
  - b. Building Your School
  - c. Function PTA/PTSA Event
  - d. Select the Start Date/Time and End Date/Time
  - e. Organization None
  - f. Notes optional such as the title of meeting or type of volunteer work.
- 6. Click Save
